Participants are also asked to give any feedback on the drafted School Safety Resolution being considered by the State Board of Education, which is at the end of the document.

**Discussion items considered:**

Students:

- What helps you feel safe in school?
- What helps you feel unsafe in school?
- What are you and your friends' biggest concerns about schools safety?
- What things work and don't work around the issue of school safety from your view?
- Do you have a significant adult relationship within the school? Is there an adult with which you have trust which you could ask a hard question or, or if you were in trouble is there an adult that you feel you could go to? How much of your student body do you feel has that?
- What do you feel are the most important issues that the State Board can help illuminate in state policy?

- Do you have any feedback on the drafted State Board of Education School Safety Resolution?

#### Staff & Administration

- What local programs or policies related to school safety are you implementing?
- What do you think works and does not work in terms of school safety?
- What could be done at the state level to support school safety?
- What are teachers specifically doing in the classroom to support students and help them feel safe?
- What percentage of students do you believe that have a significant relationship – one of which they feel close to and who could be an intervention if needed - within the school? Evidence?
- Do you have any feedback on the drafted State Board of Education School Safety Resolution?
