#### **Early Learning Programs**

While private school approval does not replace the licensure required for early learning and childcare programs by the <u>Department of Children</u>, <u>Youth</u>, and <u>Families</u> (<u>DCYF</u>), many private schools also offer early learning programs.

#### **Online Programs**

Washington private school law assumes a physical facility in the state where students are enrolled and regularly attend (RCW 28A.195.010(6)). Although a Washington-approved private school may offer an online program, fully online schools or those with facilities only outside the state cannot be approved as Washington private schools (RCW 28A.195.090).

#### **Extension Programs**

RCW 28A.195.010 allows an approved private school to operate an extension program for parents, guardians, or custodians to teach children in their care. Requirements for extension programs — including supervision by a certificated employee, regular contact, student progress evaluation, and limits on number of students per supervisor — are detailed in the RCW.
