DRAFT EXH A Position Statement of the State Board of Education Regarding the Benefits of High School Smarter Balanced Assessment Participation During the 2016 Assessment Cycle.

Today, the Board affirms its support for the actions of the Superintendent of Public Instruction to ensure full participation in the high school Smarter Balanced assessment this year.

Although full participation is important to ensure federal compliance, the overriding consideration is the benefit to students.

In that spirit, the Smarter Balanced Assessment serves multiple purposes. In addition to setting a career- and college-ready standard for high school achievement, and informing senior year course-taking choices, these assessments can also save students time and money for college placement. For the first time ever, students who pass can skip costly and time-consuming remedial coursework at the post-secondary level.

It's a major step forward for our state that students are now taking an assessment that is meaningfully connected to the expectations of our post-secondary institutions. We are determined to eliminate the gap between our systems, and the Smarter Balanced Assessment is an important step.

The next step is to fully support our students who are not on track for the high bar of careerand college-readiness. Gaps of any size for our students of color, and our low-income students, are unacceptable. The Smarter Balanced assessments help us understand the size of the gaps we face and help schools identify individual students who are in need of extra help. But wide-scale assessment refusals obscure those gaps, and eliminate a tool for parents and teachers to identify students in need of extra help. All students and their parents have a right to know whether they are ready for college-level work.

Washington can and should be a leader in career- and college-readiness. We therefore issue the following goals for this next assessment cycle:

- All schools meet the 95% participation requirement on the Smarter Balanced assessment for the 2016 assessment cycle.
- Washington reduces the number of students requiring remedial coursework in postsecondary by 10% this school year.

95% / 10% CHALLENGE

Today, the State Board of Education unanimously endorsed two key goals for the WA K-12 System pertaining to this year's administration of the Smarter-Balanced Assessments (SBA).

1. GOAL: <u>ALL</u> SCHOOLS MEET THE 95% PARTICIPATION REQUIREMENT

• The Board challenges all schools to meet the 95% participation requirement established under federal law and included in the State Accountability Workbook.

2. GOAL: WA REDUCES # OF STUDENTS REQUIRING POST-SECONDARY REMEDIAL COURSEWORK BY 10%

Save time. Save Money. Institutions of higher education in Washington have made it clear that the SBA is an important assessment. Students who pass the Smarter-Balanced assessment usually **qualify to skip remedial coursework altogether**. Washington can meet the challenge of reducing remedial coursework rates by 10% this year. It saves students time and money! More students taking and passing the SBA means fewer students in remedial courses.
